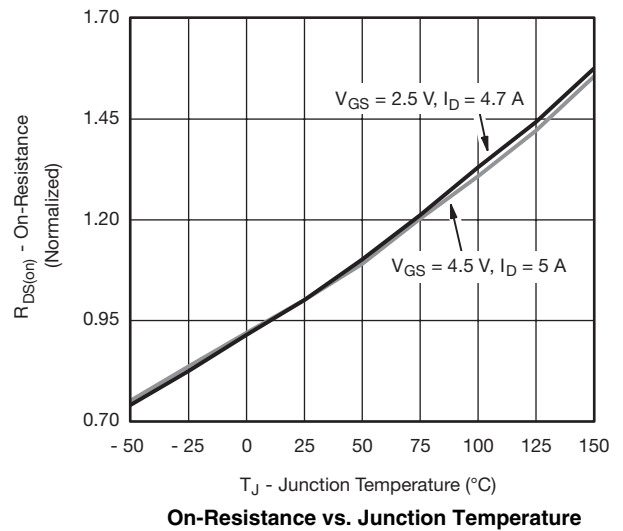
**On-Resistance vs. Drain Current and Gate Voltage**

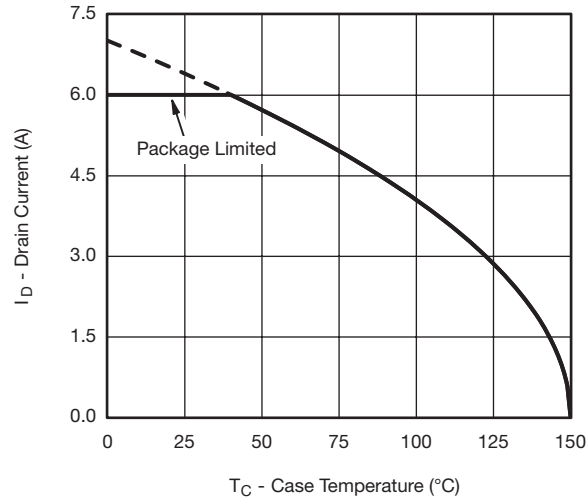


**On-Resistance vs. Junction Temperature**

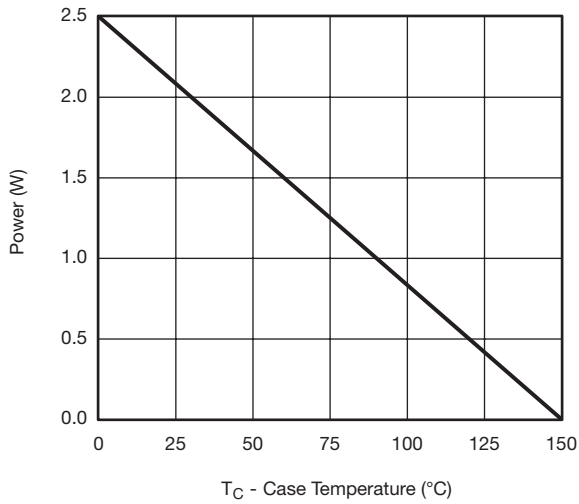

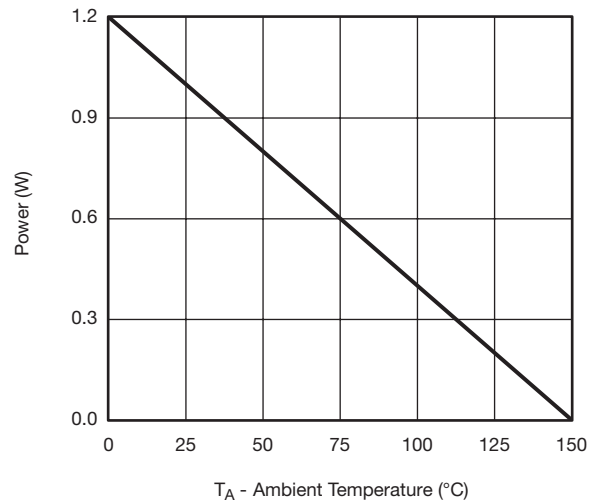
$T_C$  - Case Temperature (°C)

**Power Derating, Junction-to-Foot**

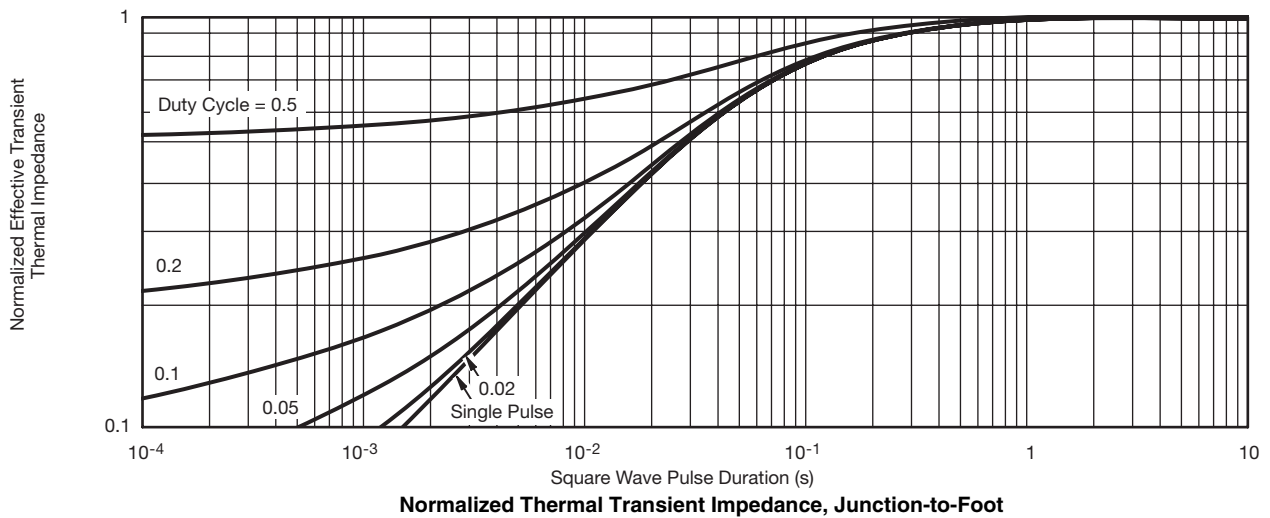
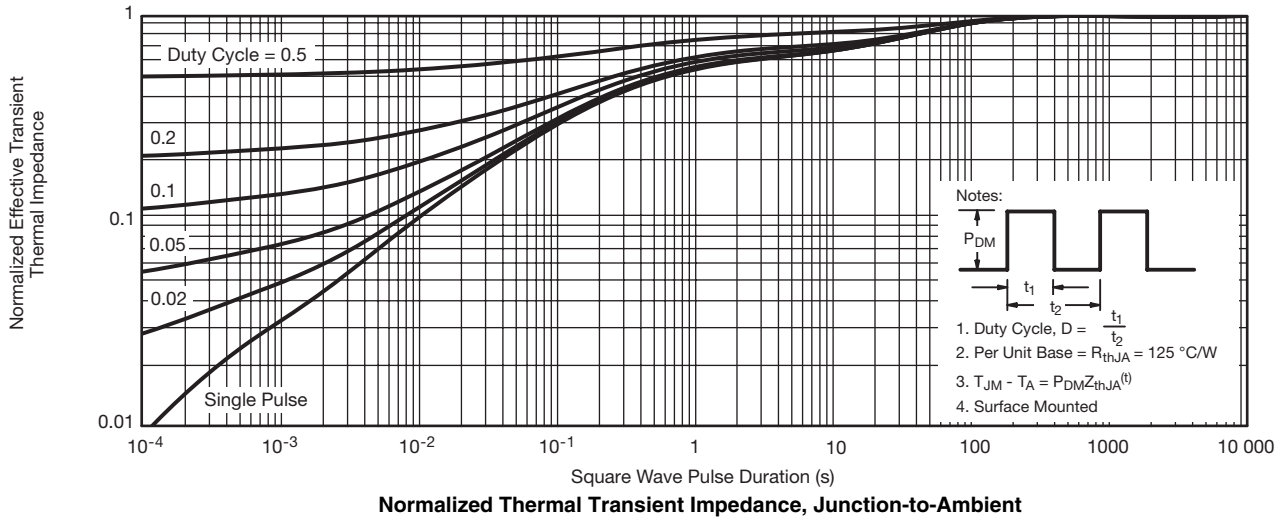
