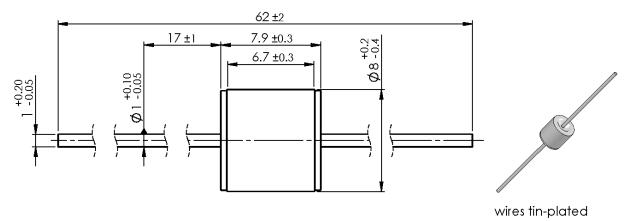

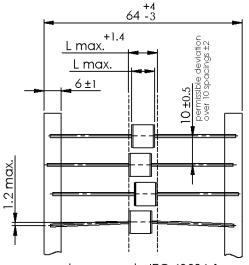

## Dimensional drawing in mm

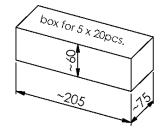

#### Cautions and warnings
