Description

The CPC1117N is a miniature normally-closed single-pole (1-Form-B) solid state relay in a 4-pin SOP package that employs optically coupled MOSFET technology to provide 1500V_{rms} of input/ output isolation. The efficient MOSFET switches and photovoltaic die use IXYS Integrated Circuits' patented OptoMOS architecture. The optically coupled output is controlled by the input's highly efficient infrared LED.

IXYS Integrated Circuits' state of the art doublemolded vertical construction packaging makes the CPC1117N one of the world's smallest relays. It offers board space savings of at least 20% over the competitor's larger 4-pin SOP relay.














Typical Blocking Voltage Distribution (N=50, I_=1mA)












Typical Turn-On Time


vs. LED Forward Current

(l,=100mA)










Typical On-Resistance vs. Temperature (I_F=0mA, I_L=150mA)

Moisture Sensitivity

We test all of our products to the maximum conditions set forth in the standard, and guarantee proper operation of our devices when handled according to the limitations and information in that standard as well as to any limitations set forth in the information or standards referenced below.


Board Wash

IXYS Integrated Circuits recommends the use of no-clean flux formulations. Board washing to reduce or remove flux residue following the solder reflow process is acceptable provided proper precautions are taken to prevent damage to the device. These precautions include, but are not limited to: using a low pressure wash and providing a follow up bake cycle sufficient to remove any moisture trapped within the device due to the washing process. Due to the variability of the wash parameters used to clean the board, determination of the bake temperature and duration necessary to remove the moisture trapped within the package is the responsibility of the user (assembler). Cleaning or drying methods that employ ultrasonic energy may damage the device and should not be used. Additionally, the device must not be exposed to flux or solvents that are Chlorine- or Fluorine-based.






Mechanical Dimensions
